An academicians representing SC/ST/OBC/Minority/Women/ Differently-abled categories, if any of candidates representing these categories it the applicant, to be nominated by the Vice-Chancellor, if any of the above members of the selection committee do not belong to that category.	<b>Dr. Divya Rani Hansda</b> Head, Univ.
