Core Course (CC): A course which should compulsorily be studied by a candidate as a core requirement on the basis of subject of M.A. Studies and is termed as a core course.

Elective Course (EC): Generally a course which can be chosen from a pool of courses (Basket) and which may be very specific of specialized or advanced or supportive to the subject/discipline of study or which provides a extended scope or which enables an exposure to some other subject/discipline /domain or nature the candidates proficiency/ skill is called an Elective Course.

Discipline Specific Selective Course (DSEC): Elective course may be offered by the main discipline/Subject of Study is referred to as Discipline Specific Elective. The University Institute may also offer discipline related Elective courses of interdisciplinary nature (to be offered by main discipline/Subject of study)

Generic Elective (GE) Course: An Elective Course chosen generally from an elective by other discipline /Subject and vice versa and such elective may also be referred to as Generic Elective.
